## Declaration of Compliance with European Union “REACH” Legislation for Full Pushbutton Boots

Part of this commitment includes the safe use and identification of chemicals per the applicable requirements of the EU Regulation (EC) No. 1907/2006, also known as REACH (Registration, Evaluation, Authorization and Restriction of Chemicals).

Under REACH, APM HEXSEAL is considered to be a downstream user. As such, we have a key role to play in advancing the safe use of chemicals and communicating relevant information to our customers.

We confirm REACH compliance via our supply chain partners. We continually work with our suppliers to ensure that all requirements are met and that they remain in full compliance with current and future REACH requirements.

As of **June 10, 2022**, the ECHA (European Chemicals Agency) has placed **224 substances** on the Candidate List of Substances of Very High Concern (SVHC). Any SVHC cannot be used, manufactured, or imported without the prior authorization of the ECHA.

APM Hexseal declares that our products listed below may contain an article made of certain Steel, Aluminum, or Copper alloys that contains the substance Lead (Pb; CAS: 7439-92-1; EC: 231-100-4) as an alloying element, which is included on the list of SVHC substances, in concentrations higher than 0.1% w/w.
